

## Waiver and Release Form for Clean Creeks FC and Sailors Dock

### Liability Release and Parental Consent Form

In consideration of the acceptance of my participation in the Clean Creeks FC or Sailors Dock programs, I hereby waive, release, and discharge any and all claims for damages for personal injury, property damages or which may hereafter occur to me as a result of participation in said event. This release is intended to discharge in advance Clean Creeks FC and Sailors Dock, its officials, officers, employees, volunteers and agents from liability, even though that liability may arise out of perceived negligence on the part of persons mentioned above. It is understood that some recreational boating and creek clean-up activities involve an element of risk or danger of accidents, and knowing those risks, I hereby assume those risks. It is further understood and agreed that this waiver, release and assumption of risk is to be binding on my heirs and assignees.

### Agreement to Follow Safety Rules and Requests

It is further agreed that the participants agree to abide by the rules of boating safety:

Always wear a PFD when using watercraft including kayaks and paddle boards; return to base camp at the requested time and not later than before dusk; return to camp, if possible, or nearest safe land at signs of inclement weather such as storm clouds, increasing winds and/or lightning; operate your vessel in a safe manner and with respect to the consideration and safety of others as well as property; act responsibly and show respect for the community which includes not playing loud music and not using inappropriate language; and obey other requests concerning Clean Creeks FC or Sailors Dock activities which may arise.

### Consent for Treatment

I hereby give my consent to have the above applicant treated by emergency medical personnel, a physician, or surgeon, in case of sudden illness or injury while participating in the above activity. It is understood that Clean Creeks FC and Sailors Dock will provide no medical insurance for such treatment, and that the cost thereof will be at my expense.

I have read and understood the foregoing registration liability release and parental consent form, and agree to all of its terms and conditions.
