Consent for Treatment

I hereby give my consent to have the above applicant treated by emergency medical personnel, a physician, or surgeon, in case of sudden illness or injury while participating in the above activity. It is understood that Clean Creeks FC and Sailors Dock will provide no medical insurance for such treatment, and that the cost thereof will be at my expense.
